•Which banking institutions sign up the credit card payment services?

•How do I make a payment by credit card via e-Filing?

A downloadable electronic tax-filing program, available at https://tax.nat.gov.tw or https://www.ntbt.gov.tw. is necessary for you to file individual income tax returns and make credit card payments at the same time. Just login, follow the program's instructions, select "Pay by credit card" and type in the information of taxpayer's (or spouse's) credit card number to get the authorization.

Am I qualified for the e-Filing?

Any foreign national (not including Mainland Chinese) with a valid Alien Resident Certificate (ARC) or ROC Resident Certificate or Entry and Exit Permit is qualified for the "e-Filing".

How do I start the e-Filing?

Login the e-Filing program with a Financial Certification Authority (Financial CA), a National Health Insurance Card (NHI card), an Aliens Citizen Digital Certificate, or your ID No. (ARC No.) as well as Passport/Residence/ Permit No." and follow the instructions of the program to file individual income tax.

What is a Financial CA?

A Financial CA is an electronic ID provided by local commercial banks, securities dealers, etc, to authenticate the user's identity for transactions via the Internet. For more information with respect to Financial CA, please contact your financial institutions. By logging in the e-Filing system with your Financial CA, your basic information, entry and departure dates data, income and deductions data may be directly downloaded into the e-Filing program.

How to file taxes with National Health Insurance Cards (NHI cards)?

By applying for the NHI cards network service which lis provided by National Health Insurance Administration Ministry of Health and Welfare, you can login the e-Filing system with the registered NHI card and password. Following the instructions of the program to download income and deductions data (including entry and departure dates data) and file individual income tax.

•Filing taxes by Aliens Citizen Digital Certificates

A foreigner, who is equal to or over 18 years of age and holds the Aliens Resident Chip Certificate, may go to immigration agency's service stops for an aliens citizen digital certificate. You may download income and deductions data (including entry and departure dates data) and file your individual income tax by the aliens citizen digital certificate. (Service line of the certificate authority of M.O.I.: 0800080117)

•How can I file my taxes if I don't have a Financial CA, a registered NHI card or an **Aliens Citizen Digital Certificate?**

You may still be able to login the e-Filing program by entering your ARC No. as well as Passport/Residence/ Permit No. (as specified on your ARC or Entry and Exit Permit as of January 31, 2021) for the filing. You will be asked to type in the required data by yourself. However, if you have obtained the "Inquiry Code" from the tax authorities, you may download your basic information, income and deductions data from the e-Filing program by using the Inquiry Code".

When can | file my 2020 individual income tax online?

From May 1 to June 30, 2021. No extension shall be allowed.

What kind of paper documents should I submit to the tax authority after e-Filing? When is the deadline for sending those?

Any proof required substantiating itemized deductions, income from employer(s) outside the ROC for service render in ROC, the supporting of dependents, receipts for cash tax payments etc. shall be required. Generally speaking, a "list of supplementary documents for aliens filing individual income tax" generated by the e-Filing system shall contain such information that may be required for your filing. You should submit those required documents in person or send it by post before July 12, 2021.

What if I made mistakes on my e-Filing?

You may make amendments before June 30, 2021 by operating the same system then re-uploading. (Previous filing record will be replaced by the latest amendment up to five times per day.)
